Financial Update - John E.

---> All members are welcome to full details from the Treasurer's Report - join us for a monthly board meeting!

25 members currently (counting Google member as 1). Projection for Robertson Rd property makes it work with 26 members - renting two offices adds a positive revenue on top, or breaks even with 10 members.

Recap: Radio Ad

We took advantage of a deal from 3 radio stations to play recorded spots advertising us, plus a web page talking about us and the coupon - 50% off membership for the first month. The stations take 50% of that income, leaving us \$12.50/mo per member. Started May 6th, running for a month.

Option to Move (4421 Robertson Rd. on September 1st.)

Description and discussion.

VOTE: Yay - 10 (One fake no just to be obstructionist/funny)

Real No - 0, Abstentions - 0 Board votes: 5 yays (100%)

➤ Motion Passes to move: Board is approved to sign a lease to move into 4421 Robertson Rd on September 1st, 2015.

Spending up to \$200 to expand loft.

Description and discussion. Pros: more usable space during garage sale-apalooza.

Cons: spending money that we won't get back when we leave.

VOTE: Yay - 6, Few Nays. Motion passes to build the loft.

Additional Motion: if we're not paying (all the) rent, we could offer the members a free

month. People can still choose to pay, but also have the option not to pay.

VOTE: Motion passes to offer free July membership to existing members.
