<u>Financial Report</u>

- Bank account summary from last month
- Membership at 22 currently, having gained and lost a few
- Non-profit status JT's lawyer is willing to file it. Suggestion made to get examples from i3 and other makerspaces
- Liability Insurance search JT talked with his agent, LVL1 (Lousville) suggested using local agent, i3 (Detroit) shared their company name.
- Projections for new location 35 members covers \$1,500/mo rent, plus utils, internet and insurance, with ~\$300 surplus.
- EAC member, Angel, is leaving at the end of the year, so our Dickinson rent will go up \$100 to \$700/mo.

Report from Location Scouts

• Advance St - 2 offices, big warehouse, taller ceilings, 3,000 sq ft (725 sq ft of that is office), \$1,560/mo (triple net included), \$80/mo is what current tenants pay for gas/electric. Some electrical could be added -

realtor says ask current (Electrician) tenants to bid it for landlord. Possible to expand to neighboring "shotguns" in building. Parking out front, plus large parking lot in back.

- Bryan haven't seen. 3,500sq ft (500 sq ft office), \$1,500/mo including triple net.
- JT's lead 2,500sq ft space "3 blocks from here", \$500/mo, needs some insulation/door draft improvements. Not on market so no competition.
- Fish Hatchery is acceptable area, S. Park not so much.
